### **SUMMARY**

In accordance with AMC 2.54.010, surplus property having a residual value of more than \$10,000 requires the approval of the City Council prior to offering the surplus property for public sale. City staff is requesting approval to dispose of the items declared as surplus property. After approval is granted by the City Council, the vehicles and equipment will be offered for public sale using *GovDeals*, an online marketplace for government agencies to sell surplus property.

### POLICIES, PLANS & GOALS SUPPORTED

City Council Goals

- Maintain Essential Services
- Continue to leverage resources to develop and/or enhance Value Services

Department Goals:

- Maintain existing infrastructure to meet regulatory requirements and minimize life-cycle costs
- Maintain and improve infrastructure that enhances the economic vitality of the community
- Evaluate all city infrastructure regarding planning management and financial resources

### **PREVIOUS COUNCIL ACTION**

On March 5, 2019, the City Council approved and granted authority to City staff to conduct online auctions through *GovDeals*, an online marketplace for government agencies to sell surplus property. City staff anticipates bringing similar requests to Council on a bi-annual or annual basis.

### **BACKGROUND AND ADDITIONAL INFORMATION**

Prior to offering surplus property for public sale on *GovDeals*, City staff conducted an annual sealed bid auction, which was labor intensive storing and handling surplus items for a year, setting up and facilitating the sealed bid auction for 2-3 weeks and then buyers having one (1) week to pay and pick up the items they bought. City staff researched alternative options to the annual sealed bid auction, and determined the services provided by *GovDeals* would be beneficial to the City by cutting out the time and labor required to facilitate a sealed bid auction and eliminating the risk of liability to the City having the public continuously coming and going during work hours to view the surplus property being offered for sale in a sealed bid auction at the City's Service Center.

Disposing of surplus property in an online auction, allows the public to continue to participate in the sealed bid auction process. Online auctions give the City the ability to sell to a larger audience, which has the potential of higher returns on auction items. Equipment can be disposed of on a more regular basis (quarterly) allowing for less storage, handling, repairs and potentially a higher resale value. All items are typically offered "as is". City staff sets a reserve minimum price on most of the vehicles and equipment based on estimated value at the time of disposal to ensure a minimum amount is received for those auction items.



Fleet staff strive to maintain a fully functional operational fleet (vehicles and equipment) that allow employees to perform their essential job functions for the community. There comes a time when repair and maintenance costs for fleet vehicles or equipment become too costly when compared to the purchase of a new vehicle or piece of equipment. For example, in the first few years of a vehicle's life repairs include brakes, fluid changes, minor electrical issues and after the first few years' items like transmissions and major engine components can require repairs at a significant cost. Not only do older vehicles become an issue due to repair costs, but one must also consider the time and how often the vehicle is out of service due to repairs and how that can impact job functions and schedules. Not only are fleet vehicles replaced over time due to heavy usage, multiple users, age and maintenance costs, but also as new technology becomes available and/or when changes in job requirements require upgrades for staff to safely accomplish their essential job functions.
