**DOG FRIENDLY PARKS AND AREAS POLICY**

Dogs are allowed on-leash within the Ashland Trails System, and in the following open spaces:

- Burnson Property
- Cottle Property
- Granite Street Property
- Hald-Strawberry Park
- Kestrel Property
- Lawrence Property
- Liberty Street access
- Oredson-Todd Woods
- Siskiyou Mountain Park
- Bear Creek Greenway Trails

Dogs are allowed on six (6) foot (maximum) leashes on paved surfaces, or within six (6) feet immediately adjacent to paved surfaces, in fourteen (14) neighborhood parks, with the exception of children's playground areas, community gardens and ball fields:

- Ashland Creek
- Bluebird
- Calle Guanajuato
- Clay Street
- Dog Park<sup>1</sup>
- Garden Way
- Garfield
- Glenwood
- Hunter
- Oak Knoll Golf Course<sup>2</sup>
- Railroad
- Scenic
- Sherwood
- Triangle

<sup>1</sup> Dogs are allowed off-leash at the Dog Park.

<sup>2</sup> Oak Knoll Golf Course has the following restrictions: 1) Dogs prohibited at all times from walking on sensitive areas of the course, including but not limited to greens, tee boxes and bunkers; and 2) Dogs prohibited from the golf course itself when golfers are on the course.

Dogs are **NOT** allowed at two (2) parks:

- Lithia Park (due to close proximity to creek / naturals areas / wildlife); except for paved surfaces and the old Pioneer Street trail
- North Mountain Park, including the sports fields (due to close proximity to natural areas / wildlife); except for the Rocky Top section (southeast portion of park) where WoofWaste stations and signage are installed (dogs are not allowed in the playground at Rocky Top)
