Emergency Preparedness Bill

As I compile the March newsletter in late-February, I am compelled to share information regarding a State Bill focusing its effort in disaster preparedness. With a little help from local volunteers, I believe the summary of the Bill might be interesting for our readers. Obviously, our office (Ashland CERT collectively) has no political stance of the bill other than providing general information to our readers who share a passion for preparedness.

The funding request, packaged in SB 1537, is accompanied by a comprehensive policy to address overall emergency preparedness related to a natural disaster including, a campaign to ensure Oregonians have two weeks of supplies ready; safety assessments on high-risk dams for seismic updates and upgrades; and updates to Oregon's resilience plan and coastal resilience plan. The overall package seeks a \$12.7 million investment for implementation.

Thanks to one of our awesome volunteers, I am able to break down a summary you will not find on the internet including the basic directives from each section of the bill.

Section 1

OEM to develop and administer a "Two-Week Ready Oregon" program, which has already begun as "Be Two Weeks Ready".

The program is to reach 250,000 Oregon households.

OEM to partner with various governments, NGO's, business, others, to assess readiness and assist households in becoming 2-weeks ready.



Section 2

OEM Director to establish a Two-Week Ready Task Force to:

Consist of seven representatives of: local, state, tribal and federal government; NGOs; private sector; and academia.

Advise OEM on development of the program.

Analyze current preparedness data, community demographics, preparedness impediments, existing resources and gaps.

Recommend methodology to:

assess number of current 2-weeks ready households, and track progress toward program goals.

Recommend methods to ensure culturally and linguistically competent outreach to populations/communities that are:

low-income, rural, geographically isolated, and/or underserved

Section 4

Higher Education Coordinating Commission to issue a \$7,500,000 grant to University of Oregon to construct 10 seismic stations by 6/20/2023, as part of the ShakeAlert earthquake early warning system.

Section 5

Treasurer may issue bonds to raise the \$7,500,000 for the above grant.

Section 6

OEM to develop earthquake safety educational outreach campaign to raise awareness of the ShakeAlert early warning system and to educate the public on protective measures to take.

The campaign must include:

outreach to low-income, underserved, rural, geographically isolated communities,

incorporation of drop, cover, and hold materials,

evaluation of messaging efficacy,

development of evaluation metrics,

creation of multimedia content for traditional and social media, and

age-appropriate educational resources.

Section 7

OEM to create advisory committee of 15 members, sunsetting on 1/2/2024, to advise the office on this campaign.

Section 9

By 9/30/2021, Oregon Homeland Security Council to identify 10 locations to serve as staging areas.

Staging areas to provide safety, humanitarian and other short-term recovery services.

Council to consult with OEM, State Resilience Officer and emergency management agencies /program managers.

Council to determine requirements for staging areas for:

safety and security measures,

storage capacity,

Independent energy supplies,

communication capabilities,

traffic management and control equipment,

medical supplies, and other necessary resources

Section 10

OEM to develop grant program for establishing and maintaining staging areas.

May issue grants to develop Type 3 All-Hazard Incident Management Teams.

May issue grants for up to two Incident Management Teams per staging area.

Section 11

OEM to issue grants to:

establish one staging area before 9/30/2022

develop one Type 3 All-Hazard Incident Management Team by 9/30/2022.

Before 9/30/2022, develop strategic plan for establishing additional management teams:

operational beginning 7/1/2023, and

four every two years over the 10-year period.

Section 12

Water Resources Department to evaluate dams for safety issues, including seismic and extreme flooding events.

Section 13

Department to establish an 11-member Dam Safety Task Force

appointed by the Water Resources Director, in consultation with the Governor.

task force to identify ways to prioritize dam repairs and safety projects and evaluate and recommend funding mechanisms.

Section 15

State Resilience Officer, consulting with Portland State University, to update Oregon Resilience Plan by 12/1/2021, to include: long-term resiliency plan for state, local and tribal governments; and the private sector.

resiliency scorecard to assess state and local capabilities to respond to and recover from emergencies.

update by the Seismic Safety Policy Advisory Commission, in consultation with the Resilience Officer, of the Resilience Plan chapter relating to coastal communities, to include:

outreach plan to ensure inclusion of underserved communities in state and local resiliency plans;

recommendations for best practices for large-scale debris removal;

recommendations for mitigation strategies of addressing consequences of disconnection from transportation networks, power grid or other infrastructure;

update of boundaries of tsunami inundation zone, via public process.

Section 16

The bill appropriates \$2.7M to the Oregon Military Department for:

development and administration of the Two Weeks Ready Oregon Program

creation of Two Weeks Ready Task Force

development of grant program for staging areas

development of:

one staging area by 9/30/2022

one Type 3 All-Hazard Incident Management Team by 9/30/2022

strategic plan for additional Type 3 All-Hazard Incident Management Teams - four every two years over the 10-year period, beginning 7/1/2023.

Section 17

The bill appropriates \$375,000 to the Oregon Military Department for:

earthquake safety educational outreach campaign

advisory committee for developing outreach campaign

Section 18

The bill appropriates \$2M To Water Resources Department for:

evaluation of dams

creation of Dam Safety Task Force

Section 19

The bill appropriates \$125,000 of Office of the Governor for the State Resilience Officer to carry out the Resiliency Plan Update Many of you involved in supporting ShakeAlert in Oregon shall be keeping an eye on this I imagine.
